

PARTICIPATION TERMS

Our company organizes a Contest - Draw for our customers staying at the hotels Galaxy, Patras Smart and Achaia Beach from October 7th until December 16th 2016, the winner of which shall receive a prize of a travel package of his choice, choosing between three packages provided by Manessis Travel, under the following terms:

- **1.** Participation in the contest draw requires and entails automatically the unconditional acceptance of the following terms, as well as the official rules and relevant to the contest decisions of the Organizing Company, which are final and binding.
- 2. Entitled to participate in the contest are all customers who have or will have stayed overnight at the hotels Galaxy, Patras Smart and Achaia Beach until December 16th 2106 ("Duration of the Contest-Draw"). The entry form will be given to those entitled upon issue of the respective invoice of services and on condition of the payoff of the afore mentioned invoice. The customer must then complete the form with the requested details and place it in the special transparent ballot box at the reception area of the above mentioned hotels.
- **3.** The Draw will take place in Athens on December 20th 2016 at the headquarters of the Organizing Company, so as to accrue the Winner (hereinafter referred to as the "Winner"). Following the draw, a representative of the Organizing Company will contact the winner via message either to the email account or the correspondence address stated in the entry form or any other appropriate means deemed by the Organizing Company, so as to inform her/him that she/he have been accrued the Winner and any further procedure to receive the prize from the headquarters of the company at 23, Alexandroupoleos Street 23, in Athens, Greece.

- **4.** The **Prize** of the contest-draw, which will be given to the winner, is one of the following travel packages (Hereafter referred the "Prize") provided by Manessis Travel agency:

- 3 nights with breakfast at the hotel SANTA FE in DISNEYLAND
- Entry cards for all performances in both parks in DISNEYLAND
- Airport taxes
- Insurance

The cost of the trip is estimated for travel dates until 28.03.2017 and is not valid on holiday's periods, exhibitions, conferences and special events in general.

- (ii) Trip for two (2) people in **Venice** in 4 * Hotel ROYAL SAN MARCO or a similar one. The package above includes:
- Airline tickets at economic fare with ALITALIA KLM without luggage. (Extra charge per baggage is € 60)
- 3 nights with breakfast at the hotel ROYAL SAN MARCO
- Airport taxes
- Insurance

(Not included the city tax, if exists, will have to be paid on the spot at the hotel)

The cost of the trip is estimated for travel dates until 31/03/2017 and is not valid on holiday's periods, exhibitions, conferences and special events in general.

- (iii) Trip for two (2) people in **Amsterdam** in a 4* hotel or a similar one. The package above includes:
- Airline tickets at economic fare with AEGEAN or KLM without luggage. (Extra charge per baggage is € 60)
- -3 nights with breakfast at the hotel NH AMSTERDAM MUSEUM QUARTER
- Airport taxes
- Insurance

(Not included the city tax, if exists, will have to be paid on the spot at the hotel)

The cost of the trip is estimated for travel dates until 31/03/2017 and is not valid on holiday's periods, exhibitions, conferences and special events in general.

- 5. The Organizing Company retains the right to publicly announce details about the Winner (ie first name, surname) on its website and/or in any other way may deemed appropriate within reasonable time after the above mentioned draw, as well as to perform any promotional action deemed necessary and, furthermore, to use the event in any appropriate way.
- 6. It is explicitly noted that the Winner may be cancelled as such and lose the right to receive the prize if, for any reason a) they have not appear at the headquarters of the Organizing Company at 23, Alexandroupoleos street, Athens, Greece or any other indicated location and sign the declaration of Acceptance of the Prize and receive the confirmation of the Prize, producing their identification card or passport within 30 days from the day of the Draw and b) in case it has been impossible for the Organizing Company for any reason to contact the Winner within 30 days from the day of the Draw. After expiration of the above terms of reception of the confirmation of the Prize by the Winner or the non-acceptance by the Winner of these terms, any responsibility of the Organizing Company ceases to exist and the Organizing Company will not assume any obligation towards the Winner who has not appear to receive the confirmation of the Prize or has not received the confirmation of the prize in a valid manner or has not accepted the present terms.

Participation in the contest incurs binding and unconditional agreement of every Contestant for the Organizing Company to enter their personal data in a file kept in accordance with the no. 2472/1997 law, as applicable, and the Decisions and Instructions of the Personal Data Protection Authority. After completion of the Draw under the above explicit terms, the above mentioned data will be destroyed. Participation in the promotion actions is an explicit on the part of the Contestant declaration of consent, according to the no. 2472/1997 law, for the needs of the contest proceedings and for information and communication purposes. Participants hold the right to oppose, alter or delete their personal data, in accordance with relevant legislation by contacting the Organizing Company via mail. Participants who have offered any personal data unreservedly consent that they may be used by automated or not means for the Draw by the Organizing Company for the needs and during the proceedings and completion of the Contest. Furthermore, acceptance of the Prize by the Winner institutes consent and approval towards the Organizing Company for the use of his personal data in order that the Draw and its results be publicized. More specifically, the Winner of the Contest hereby explicitly accepts to participate, when and where requested, without financial or other claims against the Organizing Company, to the promotion and publication through any means of events relevant to the Draw and the Prize. For this reason, and upon entering the Contest, the Winner explicitly accepts and unreservedly consents to the use of their personal data for promotional purposes, without prior notification and no financial or other claims against the Organizing Company, in any type of advertisement, for instance on the website of the Organizing Company or other websites, and/or any other printed and/or electronic means the Organizing Company may select for promotional purposes or with the publication of the results of the Draw, photos and other possible material where the winner is included (video etc.) on radio, on T.V., by the printed and electronic press and/or the Internet.
- 8. The Organizing Company retains the right, unilaterally, to discontinue and/or cancel the contest, alter any of its terms, change the time, manner and place of its conduct, reduce or

prolong its duration, alter the number of winners or the price with other/others of equal or greater value at any time, even within the time the contest is conducted.

The Organizing Company cannot be held accountable for delays, changes, discontinuations, cancellations, inability to conduct the Draw or award the prize due to holidays, strikes or conditions which hinder the normal conduct of the Contest or the awarding of the prize, or any other actions or omissions caused by any kind of unforeseen events and situations. Additionally the Organizing Company is not responsible for inability to honor its commitments deriving from the present document due to force majeure, war or conflict, outbreak or hostilities, legislative regulation, governmental issue or any reason beyond its control. In case the Organizing Company is unable to award the Prize, through no fault of its own, it retains the right (not the obligation) to award a different Prize of equal, lesser or greater value.

If any term appearing in this document is ruled illegal or void the validity and implementation of the remaining terms shall not be affected. In case of dispute, this will be settled according to Greek legislation by the Courts of Athens.
